We derive a portion of our income from commission and bonus payments as a result of one of our activities: the introduction and arrangement of finance facilities for our clients. We introduce business to a restricted panel of lenders including Network/LeasePlan, LEX Autolease, Alphabet and Arval (and vehicle retailers in some cases).
